NOTICE TO EXHIBITORS: IMPORTANT NOTIFICATION

OUR VENUE

KATIKATI MEMORIAL HALL (Main Road State Highway 2 Katikati, Bay of Plenty) are operating under NZ Government COVID TRAFFIC LIGHT POLICY.

Presently (18/01/2022) Katikati is operating at level "Orange". To ensure that no restrictions are imposed on the number of people in the hall at any given time All exhibitors, club members, Officiating Judges and members of the public are to be double vaccinated, there are no restrictions on the number of people permitted in the Hall, Lounge or Supper Room and no social distancing is required. QR Scanning by phone or sign in will be adhered to as will checking the vaccination passes - MASKS are required to be worn as this is an inside venue.

In the event that the level changes to "Red" the show will NOT be open to the public and number restrictions in the hall will be lowered to meet the criteria set.

If one or more people in the group are not double vaccinated, then numbers are restricted to a maximum of 50 people (Hall) and social distancing (two metres between each person) must be adhered to at all times. Please note that the Lounge and the Supper Room cannot take 50 people who are all social distancing, therefore numbers must be reduced to accommodate the space available ●

In classes 101-171, exhibits compete against ALL exhibits in the same section and division i.e., Longhair or Shorthair. Judging takes into account only the shape or TYPE of exhibits, but NOT coat, colour, condition or eye colour.

Breeders Award of Merit: The NZCF Inc offers a Breeders Award of Merit, one each in Entire Cat, Entire Kitten, Neuter/Spay Cat, Neuter/Spay Kitten sections of both divisions. This will be awarded at the discretion of the judge to the exhibit who, in his/her opinion, is the worthiest of the award. The certificate will be forwarded to the breeder of the exhibit. There is no class and no entry fee.

DOMESTIC & COMPANION section All Exhibits must be Neuter/Spay.

Longhair has a coat of MORE than 3cm long (approx 1 inch) and stands out from its body when brushed forwards. Hair on tail may stand out like a plume.

Shorthair is not easily brushed forward, may be flat and sleek or dense but not flowing.

Please Note:

A cat or kitten entered in the Domestic Section of a Show, which has some known pedigree, or when benched, has a phenotype or appearance of any pedigree cat, will be transferred from the Domestic Section to the Registered Companion Cat Section of that Show by the Show Secretary and/or the Show Manager in consultation with the exhibitor/owner, or agent, with the registration number shown in the marked catalogue as "pending".

Kittens must hold a current vaccination certificate with the most recent vaccination being dated at least seven (7) days prior to the show. Please ensure you have your current vaccination certificate

Exhibits entering the Companion Cats Section must meet the criteria of Rule 6 of the NZCF Registered Companion Cats Section and not have been awarded an NZCF title above Champion or Premier as an NZCF registered exhibit (unless dispensation has been given by the Executive Council). If unsure whether your cat/kitten is eligible to be shown in the Registered Companion Cat section, please contact the Show Secretary for guidance.

VETERINARY INSPECTION

Refer Shows Bylaw 8.6 – 8.13: Cats may be ultraviolet lamped. **Vaccination certificates must be produced for all exhibits.** Kitten vaccinations must be at least 7 days old; adults should have had at least one vaccination in the last three years. Please note No exhibitors to leave the hall area until all exhibits have been cleared by the vets.

CAGE CURTAINS CLUB CAGES (60cm x 45 cm)

Bedding of any colour may be used – but please respect that the Judge does require a clear view even within the cage so please do not use huge fancy beds or hammocks during judging you can use those after judging.

USING YOUR OWN CAGE

MUST include the measurements on the entry form (this assists us with setup of adequate table space)

JUDGES PROFILES

DAVID SCADDEN – Senior International All Breeds Judge



My wife Jacqui & I have been retired from the breeding game after breeding Birmans under the Magwai prefix since 1985. We both originate in the Wairarapa in the sunny Southeastern part of the North Island of New Zealand.

We moved to Rotorua, in the Bay of Plenty in 2008. One of the major tourist destinations in the country, the scenery is striking, and we are very central to other cities and beautiful destinations.

Our other great love are our Bengals, which we originally imported into the country in 1996 and bred successfully under the LapLepid prefix.

We have three children who have now left home and two grandsons.

We have two desexed Birmans, one Bengal and a Maine Coon to keep us pretty busy. Other interests include good wine, genealogy, music and collecting and restoring Ford Capri's.

I started judging in 1992 and reached the status of All Breeds in 2005, learning a great deal about all aspects of felines along the way.

I really enjoy judging and try to talk to and educate the spectators as much as possible on the various breeds. I feel that a cat show has to be entertaining and informative. I enjoy meeting fellow cat fanciers from around NZ and other parts of the world.

I have had the privilege of judging all three National shows in Australia and New Zealand over the few years and would love to be able to judge felines in other countries in the world.



ROY GRIFFITHS – Senior International All Breeds Judge

I live with my cats in the quiet suburb of Cashmere in the hills of Christchurch, New Zealand.

I have been involved with animals all my life, bred and exhibited Weimaraner's (German Hunting dog) in the Gundog ring to a level of National Champion.

Initially a Devon Rex stole my heart at a cat show. Unfortunately, at that time the mopathy problem was being controlled so I settled on Oriental and Siamese. I enjoyed these breeds and although never exhibiting them, I owned one of each to a very elderly age of 16yrs+. I managed to acquire my first Devon in 2001 and have bred and exhibited Devon Rex since. Initially focusing on an outcross program to expand gene diversity and bring the cinnamon colour into the Devon Rex gene pool.

Now with bloodlines that stretch the globe and a healthy association with some of the breeders here in New Zealand, we strive to address some of the health problems associated with the breed, striving for health first and breed standard Devon Rex and providing them with exceptional homes. My extended family and my passion are my cats.

A qualified Steward, Handler and Senior All Breeds Cat Judge and still exhibiting Devon Rexes. Have held office on the Executive Committee as the Portfolio Manager of the Breeds Standards Advisory of the New Zealand Cat Fancy.

Currently the Breed Representative for the Rex Breeds and recently helped in the updating of the Cornish Rex and Devon Rex along with the introduction of the Devon Rex Longhair as a new registered breed.

I am passionate about and really enjoy meeting fellow breeders and judges at shows and seminars. A great networking opportunity to learn and share.

Looking forward to enjoying many more hours with the cats and their servants.



CHRISTINE YEUNG: Senior Shorthair & Junior Longhair Judge

I have been owned by Burmese since I was a child - a seal named Mỳ lệt was my first cat. We also owned a Bluecream Persian and had several moggies over the years.

Mỳ lệt was entered into a show in my hometown of Gisborne, I can't remember his placings other than "The cat with the longest whiskers", which of course I thought was wonderful!

It wasn't until around 20 years later, when wanting to see what this showing thing was really all about, we entered our neuter Russian Blue into the Kapiti cat show and from there, was hooked.

My husband Mushfik and I registered the Cairistona prefix in 2003, with our first litter of Burmese and Mandalay kittens being born in 2005. Our foundation queen was from Sashima Cattery – Brz Db Gr Ch Sashima Lace, who is now a spritely 18 years old and very much enjoying the retired life!

We have bred many high achieving cats over the years, including the 2019 NZCF National Show Shorthair Supreme winner and 2019 NZCF National Awards winner for Shorthair Entire Kittens - Cairistona Vespa.

We continue to breed Burmese and Mandalays, with our Mandalays under the prefix of Mỳ lệt. We have also bred the odd litter of Tonkinese. We have two Dobermanns which are very much owned by the cats too!

My particular areas of interest are in genetics and safeguarding the wellbeing of all breeds, which includes advocating the use of valuable tools such as health screening and genetic testing. These tools facilitate us to make informed decisions within our breeding programs. I am also a strong advocate for Fear Free and Low Stress Handling, and I hold Low Stress Handling certification.

I've been involved since 2003 with Palmerston North cat Club at a number of levels from committee member to President, and almost as long with the Burmese Cat Club of NZ having also been involved at all levels with being a Life Member and the North Island region's current Chairperson. In addition, I am presently the NZCF Breed Representative for the Burmese breed group, and I am a member of the NZCF Breed Standards Advisory Council.

In 2015, I qualified as a NZCF Shorthair Judge, gaining my Senior (international) status in 2018. In 2019 I enrolled in the NZCF Longhair judges training school, achieving Junior status in 2021. I look forward to meeting many more cat fanciers, learning about their beautiful longhair cats and working my way through to gaining my All-Breeds status.

In my professional life, I am a Registered Veterinary Nurse and work in a Veterinary Teaching Hospital in the area of leadership.

For me every day is a learning day and I hope that by judging at shows, I can gain experience, learn more about each breed and along the way meet interesting and like-minded people.

I very much look forward to seeing your beautiful cats on the show bench!
