2019 NATIONAL SHOW DEBRIEF SOME IMPORTANT THINGS THAT THE HOST CLUB WOULD LIKE TO SHARE WITH THE MEMBERSHIP OF THE NZCF

Summary of Show Committee Debrief:

Host Club has received a number of emails of congratulations regarding the show honouring the work put in by a very small show committee but of course along with those messages of congratulations there have also been significant postings on Facebook which have contributed to members/exhibitors being more confused about the show format.

Despite that the club has not been contacted officially regarding **some** of the matters/concerns highlighted in media postings the show committee have decided to release the debrief report so that the club can confirm that appropriate follow up of the concerns have been either taken on board or addressed on enquiry through appropriate channels and for that opportunity the club is grateful.

It is with sincerity that Patches & Pointed hope that some of the matters or concerns highlighted are taken on board by the Executive Council to assist with Clubs who take on the hosting of a NZCF National Show (albeit no funding other than for the attendance of the Chairperson & Show Portfolio Manger is provided) The Host club is still expected to cover all costs. It should also be noted that this host club absolutely knew the risk they were to take with holding a one ring National show with very little chance of making a profit and can report the hosting of the 2019 National show has resulted in a loss for Patches — so the fund raising begins again!

We certainly do not need to remind were the biggest costs are but one in particular that it was felt by the organising committee that as NZCF have full naming rights of the National show that at least some sort of advertising budget could be looked at in the future this of course is a major expense. We were very fortunate to be able to utilise contacts established for other shows to support our production of our street signs, shop window signs, and pamphlets. However, the cost of Publication in the Newspaper/s was ridiculously high despite being provided with editorial and photographs we had to compete with the release of advertising for the Pet Expo which was to be held the following weekend of the National in Tauranga. We were not aware that the organiser of Pet Expo was to hold a show so close to that of the National show at the time of setting our date.

Despite a big effort on behalf of the Club to publish details on a number of sites the ultimate price was paid with families choosing to go to the Pet Expo the following weekend instead of the cat show.

The Club believed that every effort was made to ensure that the exhibitors were provided with documents explaining the show format and updates were provided throughout — unfortunately there is no way that the club can ensure that people read the documents.

The Executive Council accepted the Clubs initiative to add Top 15 All Breeds to the 2019 National Show and as an incentive there was to be an allocation of points to the Top 15 winners in each division.

NZCF needs to review the responsibility of the host in organising the Annual Awards dinner and also the collection of monies on behalf for the event – this host believed that there was more than enough work done without having to take this role on and believe that this practice should be taken back by NZCF.

No formal complaints were received on the day of the show regarding any aspect. The host Club have since received two requests relating to finalising of the Supreme Shorthair and subsequently three weeks post show date relating to the Supreme Longhair Exhibit. One related to panel decision on the day and an incorrect announcement being made relating to the NZCF Supreme Title. The Host acknowledge the disappointment of the exhibitors that a Supreme announcement was not done in the first instance on the day.

We are very proud of the One Ring Show and that there were 211 entries not including the on-display Templecats. A sincere message was posted to the membership/exhibitors for their support of the National asking them to support the handover of the flag to the next host Canterbury All Breeds.

A great deal of support was received from vendors leading up to show day – NZCF brand has been used with a great deal of respect and every effort was made to ensure that exhibitors, attendees at the show would take on board the work that the committee had put into the event.

Livestreaming on show day – was handled very capably by Alex Ladyman. From all accounts it was well received this was funded by Patches & Alex. The only negative was that to the best of our knowledge no coverage was placed on Patches page.

Show Format – approved

- Each Officiating Judge was asked to select Top 10 Longhair & Shorthair followed by Top 15 All Breeds.
- Each Officiating Judge was given the opportunity to nominate up to three exhibits within each breed to compete for Supreme & Runner-up Supreme of Breed (this is a Club initiative in other words a club award and therefore would not affect the Officiating Judges placings for the Supreme in Show awards).

However, it must also be noted that despite that the Executive Council were made aware that the Show Bylaw wording was not correct nothing has been done to address this matter and it is sincerely hoped that the Bylaw concerned will be updated accordingly in the next review.

Newsletters were released on a regular basis in fact 5 editions – we do not recall this ever being done before leading up to a National Show – Patches & Pointed Inc. are very proud of the number of times that this club has looked outside the square when it comes to

initiatives it should all be about giving clubs the opportunity to have ago at new ideas and not have to take on board copious negativity not only from a small focused group of exhibitors but also from the Executive Council who at times have not supported their own officers responsible for fulfilling tasks whether it be in the Portfolio areas of Shows, IT, Honours etc..

Club Initiative Supreme of Breeds Award

Supreme of Breeds was closely contested by a significant number of breeds and just as expected the panel of judges on at least three notable occasions selected other than the officiating judges BOB exhibit. It should also be noted that not all judges made nominations based on merit – they did not believe the exhibits were of sufficient merit on the day to be included in a panel judge of. We realise that may be a disappointment to some exhibitors but maybe they are the exhibitors who did not read the newsletters or the schedule correctly!! A huge thank you was extended to all those breeders and Exhibitors who sponsored these awards **See attachment Item 1**

Hall of Fame - Club Initiative



The Club received a wonderful response from previous exhibitors which enabled us to put together a fantastic "hall of fame" acknowledging 50 previous winners at an NZCF National ring dating back to 1992 to present day — it attracted a lot of interest on show day. Club received a report from one disappointed exhibitor who registered an error being made unfortunately the Club cannot afford to reproduce the poster which was funded by the club in the first instance.

NZCF Show Package

Patches being one of the NZCF Affiliate Clubs who has been utilising the show package from day dot! We must declare out disappointment that the programme STILL is not complete in fact the show committee decided to only utilise the show package for the entry process and judges sheets — as no updates had been completed for on-the-day issues that Patches or any other club had highlighted had been addressed. We simply could not risk being able to get the full results posted. It was also noted that for some reason the birth dates are now all shown as Americanised which meant that our entry clerk had to manually amend them to ensure that the catalogue details were correct. The new Honours Officer Susan Grindell must be commended for her patience along with Peter who eventually were able to set to and at least get the work out that was required in time for the show and the subsequent results.

Host response to Media Postings /Email

Refer Attachment 2 Media Postings Summary

PATCHES RESPONSE: attached are copies of the supreme of breed nomination forms (refer Attachment 1) from each officiating judge clearly showing that not all judges nominated exhibits to go forward to the supreme of breed section...this was a based on merit in the officiating judges opinion and they were very focused on what the nomination process was in that they made their decision on merit as to which cats came forward. The officiating judges thereby nominating exhibits that they believed were the best representation of the breed so that each judge had the opportunity to access the nominations against the exhibit that they had judged. Judges were instructed that they could nominate up to three exhibits in each breed to be assessed by the panel. Two judges were approached to make sure that they understood the nomination process when they had not nominated more than one exhibit or no nomination at all.

The Supreme of Breed was never advertised or linked to the National Show overall results, this was a Club initiative and was sponsored in full by participating breeders, exhibitors or businesses. An attempt to add another layer of interest to the show utilising the expertise of the panel of Judges.

The Club has taken on board the concern regarding the runner-up decision being made first however, it was only evident in three breeds that this was challenged when it was the officiating judge who stood down in the vote. The NZCF Appointed Referee Judge (David Scadden) requested that a visiting international all breeds judge (from Australia) be involved in a deadlock vote for Supreme Burmese – after inviting Chris M Lowe to judge this was declined as she had been involved in the administration of the show.

This is the award that caused confusion on the day – an incorrect announcement was made by the Show Coordinator minutes later after consultation with referee Judge was corrected however, (neither of the affected exhibitors were in the ring at that time they were with the photographer) No approach was made to rectify any award on the day – it was on the 16th that the first enquiry was received and this required follow-up with the officiating panel to make a decision. A replacement Rosette (and Supreme Prize) has been provided to the winner of the shorthair supreme and on receipt of a letter of the 31st June an explanation and apology was provided to the Longhair exhibitor for the incorrect announcement
